Summer Skip a Pay is Here For One More Month



Qualifying Freedom Members with an auto or personal loan who received our Skip-a-Pay postcard, may skip one payment this August for a low \$28 processing fee.* This time, we've made it even easier to skip your payment. Simply visit FreedomCU.org and click on the homepage banner. Enter your loan information and your next payment will be skipped. Please note that the only way to skip your payment is online and that if you have more than one loan you'd like to skip, you will need to enter them separately.

*In order to qualify for this promotion, all Accounts and Loans must be in good standing and each Loan cannot be skipped more than twice per year (once per promotion period). After skipping the payment, your regular monthly payments will resume in accordance with your existing payment schedule. Interest will continue to accrue during the month skipped and your term will be extended by one month. If you miss your loan payment due date for the month the Skip-A-Payment online form is due, your skip will be declined even if we received the online form on time. The \$28 processing fee per loan will be automatically deducted from your Checking Account and the funds must be in your Account at the time your application is processed or it will be declined. If you do not have a Checking Account, the fee will be taken from your Primary Savings Account. Loan payments can be skipped only on Personal or Vehicle Loans.

Avoid Online Banking Fraud

At Freedom Credit Union, your online security and identity is of the utmost importance to us and we want you to know that we are doing everything we possibly can to ensure that your information remains safe with us. Here are a few tips you can follow to avoid your information getting into the wrong hands:

- Be sure to use unique passwords for all financial online accounts.
- Change your passwords every 60 days for all financial accounts.
- Do not save credit or debit card, banking account or routing numbers, or other financial information, on your computer, phone or tablet.
- Be careful about using a password on mobile devices be sure to set your devices to automatically lock after a selected period of time to ensure no one can access your smartphone, tablet or laptop.
- Do not provide your secure financial information over the phone or Internet if you are unsure of who is asking for it - remember, your financial institution will never contact or text you asking for personal or banking information.
- Be aware of the location of your mobile devices (smartphones, tablets) at all times and only log on financial websites when you have a secure, safe and trusted Internet connection.
- Run anti-virus and malware protection programs to actively monitor and secure your PC.
- ✓ Use extreme caution when using public computers and avoid accessing sensitive data that could be captured by the host providing free access.
- Contact Freedom Credit Union immediately if you think your online identity has been compromised because the sooner you alert proper authorities about suspicious activity, the sooner it can be resolved.
